- All applications are due **Friday, November 14, 2025**. Full payment is due at the time the contract is due.

The sale of certain items, including but not limited to the following, is prohibited: weapons, drug paraphernalia, provocative or suggestive items, and graphic images that may offend a family-friendly audience.
